1. About the award

The DT4regions award gives visibility to the best solutions such as initiatives and technological applications) based on Artificial Intelligence and Big Data currently in use by public administrations in Europe. Government in Europe are doing efforts to integrate AI and big data solutions into their operation and for improving services to citizens. From an analysis performed by AI Watch* it emerged that the AI is particularly used to support redesigning governance processes and policy-making mechanisms, as well as to improve public service delivery and engagement with citizens.

The DT4regions awards aims to encourage a bottom-up sharing of best practices, solutions, applications and initiatives adopted by national and regional governments or by public authorities at all levels so to increase mutual learning. Awarding the most successful cases of AI and big data implementation will serve to help scaling these solutions to further Member States.

2. Who can participate?

The DT4regions award is open to all civil servants, representatives of public administrations and members of European regional and national authorities that are aware of an initiative, application or successful solution based on artificial intelligence and big data adopted by public administrations in Europe.

4. How to participate?







Civil servants, representatives of public administrations, regional and national authorities can nominate an initiative, applications or solution based on artificial intelligence and big data, they are aware of, by clicking on the "Apply Button". A sample of the application form can be previewed here. Each entrant can candidate one or more initiatives, applications or solutions providing all data to its best knowledge. It is of course possible to candidate initiatives belonging to one's own region, city, nation or public administration but each entrant can also candidate initiatives of which he/she is aware of, belonging to other countries or public administrations.

In April 2023 the winners of the award will be announced and awarded with a graphic label in two categories:

- 1. Selected and awarded by an expert jury
- 2. Public's Favorite
- 2. Selected and awarded by the DT4regions platform's users


- 1. Who can candidate an application? Representatives of European Public administrations that have developed applications based on Artificial Intelligence and Big Data or use applications based on AI and BD developed for them by third parties.

Civil servant submitting a solution might be required to submit additional resources related to the solutions upon request in a second stage
